Hartley City Council Meeting Regular Session April 10, 2023

A regular meeting of the Hartley City Council was held Monday, April 10, 2023, at 5:30 P.M. at the Hartley City Hall. The meeting was available in person and via Zoom.us at 833 7445 6871, Password 342713 and/or by phone at 312-626-6799. Log in details were included with the posted meeting agenda. Mayor Rodney Ahrenstorff presided and called the meeting to order at 5:30 P.M. City Councilmembers present were Mary Westphalen, Roxann Swanson, Nick Galm, Jerry Olson, and Ron Hengeveld. Kaity Pedley provided an annual update on the Hartley Community Daycare Center. The center is at capacity with a long waitlist. The building is currently in need of some major repairs. Pedley announced a \$500,000 donation the daycare received for new or renovated facilities.

Dave Vander Broek, Dan McCarty, Justin McCarty, Nicole Shaffer, and Laura Mohni were present to give an update on the rec trail proposal. The committee was awarded a \$100,000 grant to be used on a trail from Neebel Park on 3rd St. SW to 8th Ave. W. They also received a grant for RRFB highway crossing, which are proposing to do near the school. In addition, they are proposing an in-town bike route on city streets. They plan to apply for a grant to cover the cost of signage.
