

**Hartley City Council Meeting
Special Session
May 24, 2021**

A special meeting of the Hartley City Council was held Monday, May 24, 2021 at 5:30 P.M. at the Hartley City Hall. Electronic access information was included in the posted agenda of this public meeting. Mayor Rodney Ahrenstorff presided and called the meeting to order at 5:30 P.M. Olson moved to adopt the consent agenda. Seconded by Hengeveld. Roll Call: Ayes. Westphalen, Myers, Olson, Hengeveld, Swanson. Nays. None. Motion carried 5-0.

Mayor Ahrenstorff opened the public hearing for the USDA Rural Development grant application for purchase of bucket truck for the Electric Department at 5:31 PM. No written or oral comments were received. Mayor Ahrenstorff closed the public hearing at 5:32 PM.

Hengeveld moved to approve **Res. No. 2021-25, "A RESOLUTION APPROVING APPOINTMENT AND WAGE OF UTILITY BILING CLERK/ADMINISTRATIVE ASSISTANT."** Seconded by Swanson. Roll Call: Ayes. Westphalen, Myers, Olson, Hengeveld, Swanson. Nays. None. Motion carried 5-0.

A discussion was held regarding attaching a blade on the back of the tractor. Myers approved the bid from Jaycox Implement, Inc. for Land Pride blade for \$5,750. Seconded by Swanson. Roll Call: Ayes. Hengeveld, Swanson, Westphalen, Myers, Olson. Nays. None. Motion carried 5-0.

Westphalen moved to approve the bid for 2021 street patching/paving & seal coating from Blacktop Service Co. for \$54,585. Seconded by Olson. Roll Call: Ayes. Swanson, Westphalen, Myers, Olson, Hengeveld. Nays. None. Motion carried 5-0.
