# Garbage Notice:

If you are needing to throw away construction materials, Brommer Sanitation asks that you either, make arrangements with them for separate pick up or rent a dumpster from them. Rigid construction materials are much easier for the rear load garbage truck to handle than the side load truck. Brommer Sanitation (712) 722-0631

Remember that garbage and recycle totes are property of the City of Hartley and any damage to totes due to customer neglect will result in repair charges assessed to the customer. Once your garbage or recycling has been dumped the tote shall be promptly removed from the curb line, this will help keep your totes from being damaged

Garbage containers cannot be used for recycling and recycle containers cannot be used for garbage. If the wrong container is used it will not be dumped. Additional totes are available for an extra charge. Contact City Hall to inquire on additional containers. The Iowa Association of Municipal Utilities (IAMU), through its Education and Research Fund. is pleased to offer two scholarship programs for graduating Iowa high school seniors and recent graduates - a scholarship program for students pursuing a post-secondary program with a utility focus and a general scholarship program for children or grandchildren of IAMU members. A minimum of four \$1,000 utility focused scholarships will be awarded and a minimum of four \$500 general scholarships will be awarded. Scholarships will be awarded by May 1, 2022. Missouri River Energy Services (MRES) has established a scholarship program to assist high school seniors with educational pursuits that are related to the electric industry. Up to 12 scholarships will be granted each year in two categories. Up to five \$1,000 scholarships will be awarded for full time undergraduate studies with course of study related to the electric industry. There are also up to seven \$1,000 scholarships awarded to students who are pursuing studies in a powerline/lineworker program at an eligible technical college. The scholarship application opens Jan. 14, 2022 and closes at 3:00 P.M. CST on March 15, 2022. Letters of recommendation are due no later than 3:00 P.M. CST on March 18, 2022.
