A regular meeting of the Hartley City Council was held Monday, November 14, 2022, at 5:30 P.M. at the Hartley City Hall. Mayor Rodney Ahrenstorff presided and called the meeting to order at 5:30 P.M. Olson moved to adopt the agenda. Seconded by Hengeveld. Roll Call: Ayes. Swanson, Galm, Olson, Hengeveld. Nays. None. Motion carried 4-0.

Galm moved to adopt the consent agenda, including the liquor license renewal for the Stoplight Lounge. Seconded by Swanson. Roll Call: Ayes. Galm, Olson, Hengeveld, Swanson. Nays. None. Motion carried 4-0.

Mayor Ahrenstorff opened the public hearing on the Proposed Amendment to the Hartley Urban Renewal Area at 5:31 PM. No written or oral comments were received. Mayor Ahrenstorff closed the public hearing at 5:32 PM.

Mayor Ahrenstorff opened the public hearing on the Proposed Development Agreement with Monica and Wyatt Glime at 5:33 PM. No written or oral comments were received. Mayor Ahrenstorff closed the public hearing at 5:34 PM.

Brian Myers, Candy Ruschmann and Pam Sease of the HEART were present to update the Council on the volume of calls they have managed in recent months. They requested that the Council consider the future purchase of a used ambulance for transports and an expanded garage to store the ambulance.

Aaron Olson of T.P. Anderson & Co. presented the City's audited financial statements for the year ending June 30, 2022.

Benz gave an update on the NIPCO transmission line switch installation project being planned. Galm moved to approve the NIPCO Electric Facilities Construction and Reimbursement Agreement. Seconded by Swanson. Roll Call: Ayes. Galm, Olson, Hengeveld, Westphalen, Swanson. Nays. None. Motion carried 5-0.

Westphalen moved to approve the Annual Street Finance Report. Seconded by Olson. Roll Call: Ayes. Olson, Hengeveld, Westphalen, Swanson, Galm. Nays. None. Motion carried 5-0.

Hengeveld moved to approve the Annual Financial Report for FY 2021-2022. Seconded by Swanson. Roll Call: Ayes. Hengeveld, Westphalen, Swanson, Galm, Olson. Nays. None. Motion carried 5-0.

Westphalen moved to approve the Annual Urban Renewal Report for FY 2021-2022. Seconded by Olson. Roll Call: Ayes. Westphalen, Swanson, Galm, Olson, Hengeveld. Nays. None. Motion carried 5-0.

Galm moved to approve the Annual O'Brien County Tax Increment Finance Indebtedness Certification. Seconded by Hengeveld. Roll Call: Ayes. Swanson, Galm, Olson, Hengeveld, Westphalen. Nays. None. Motion carried 5-0.

In other business, Benz updated the Council on what caused some residential sewer system backup issues that occurred with the rainfall last week along with steps taken to remedy the situation and prevent issues in the future.

Hengeveld moved to go into closed session under Iowa Code Section 21.5(1)(c) and 21.5(1)(j). Seconded by Galm. Roll Call: Ayes. Galm, Olson, Hengeveld, Westphalen, Swanson. Nays. None. Motion carried 5-0.
