## **ORDINANCE NO. 348**

AN ORDINANCE AMENDING THE CITY OF HARTLEY, IOWA 2016 MUNICIPAL CODE OF ORDINANCES BY ADDING CHAPTER 69 PARKING REGULATIONS SECTION 69.05, NO. 5 PARKING FOR CERTAIN ILLEGAL PURPOSES AND REPEALING AND REPLACING SECTION 69.06 PARKING PROHIBITED, NO. 17 AREA BETWEEN LOT LINE AND CURB LINE IN LIEU THEREOF

WHEREAS, The City Council wants to define illegal parking and have a process to remove illegal parking violators; and

Be It Enacted by the City Council of the City of Hartley, Iowa:

**SECTION 1: SECTION AMENDED:** Chapter 69, Parking Regulations, Section 69.05 Parking for Certain Illegal Purposes is Amended to Include No. 5 Nonself/Propelled Vehicles or Equipment to read as follows:

5. Nonself-Propelled Vehicles or Equipment: No person shall park or store a trailer, camper, or other nonself-propelled vehicle or equipment on any street or municipal parking lot in the city.

**SECTION 2: SECTION REPEALED AND REPLACED:** Chapter 69, Parking Regulations, Section 69.06, No. 17 Area Between Lot Line and Curb Line is repealed and replaced to read as follows:

17. Area Between Lot Line and Curb Line. The area of public way not covered by sidewalk and lying between the lot line and the curb line. This includes any vehicle with wheels, including commercial and other vehicles such as, but not limited to campers, boats, trailers, UTV's and ATV's. Exceptions to this section are for the purposed of delivering and picking up items and for construction purposes when said vehicles are actually being utilized then and there for said construction or delivery/picking up purposes or trucks or cars parked perpendicular to the roadway in the portion of driveway in the public way, but not over a sidewalk and when there is temporary city street maintenance and construction and city snow and ice removal on streets.

**SECTION 3. REPEALER.** All ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

**SECTION 4. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 5. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
